**RESOLUTION OF THE GOVERNING BOARD OF TRUSTEES OF THE  
CITRUS COMMUNITY COLLEGE DISTRICT CERTIFYING TO THE  
BOARD OF SUPERVISORS OF LOS ANGELES COUNTY ALL  
PROCEEDINGS IN THE NOVEMBER 3, 2020 GENERAL OBLIGATION  
BOND ELECTION**

**WHEREAS**, the Board of Trustees of the Citrus Community College District (the “District”) previously adopted a resolution requesting Los Angeles County (the “County”) to call an election for general obligation bonds (the “Bond Election”) to be held within the District on November 3, 2020; and

**WHEREAS**, such resolution was duly delivered to the Registrar-Recorder/County Clerk of the County of Los Angeles; and

**WHEREAS**, notice of the Bond Election was duly given; and

**WHEREAS**, on November 3, 2020, the Bond Election was duly held and conducted for the purpose of voting a measure for the issuance of bonds of the District in the amount of \$298,000,000 (“Measure Y”); and

**WHEREAS**, the Board of Trustees of the District has received from the Registrar-Recorder/County Clerk of the County of Los Angeles the Canvass Certificate and Official Statement of Votes Cast (the “Canvass”) of the Bond Election; and

**WHEREAS**, it appears from the Canvass, a copy of which is attached hereto as Exhibit “A,” that more than fifty-five percent of the votes cast on Measure Y were in favor of issuing the aforementioned bonds.

**NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE CITRUS COMMUNITY COLLEGE DISTRICT DOES HEREBY FIND, DETERMINE AND CERTIFY AS FOLLOWS:**

Section 1. That entry be made upon the minutes of the meeting that Measure Y has been approved by more than fifty-five percent of the votes cast at the Bond Election.

Section 2. That all proceedings of the District in connection with the Bond Election have been accomplished according to law.

Section 3. That the Clerk/Secretary of the Board of Trustees is hereby requested to deliver a copy of this Resolution with the Canvass to the Los Angeles County Superintendent of Schools and the Clerk of the Board of Supervisors of Los Angeles County.
