PROMISE PROGRAM

Citrus College Promise Provides Two Years of Higher Education for Little to No Cost

Citrus College is proud to offer one of the first and only two-year promise programs in the entire state of California.

The highly anticipated Citrus College Promise is designed to provide an opportunity for local students to enroll at Citrus College for little to no cost. This groundbreaking program was introduced at the college's annual K-14 Education Forum in April 2018.

The Citrus College Board of Trustees, K-12 partners, university representatives, community leaders, supporters of the Citrus College Foundation and college administrators were on hand to celebrate the program's launch. During the event, guests were invited to participate in a pledge board signing ceremony to demonstrate their support of the exciting new initiative.

Earlier in 2018, the Citrus College Foundation launched a fundraising campaign to help pay for the costs connected to this \$1 million program. The Foundation pledged a commitment of nearly \$300,000 in charitable support for the first year of the Citrus College Promise, and is considering additional, multi-year pledges to help defray ongoing costs associated with the program.

This financial support will cover enrollment fees and other college costs for first-time students, including health fees, student services fees and student representation fees. In addition, participants will receive a book grant, as well as unique student support services provided through the I Will Complete College (IWCC) program.

Additional benefits include financial aid and student success workshops, priority registration, coaching with completion specialists, scholarship opportunities, and more. Students will also receive a Class Pass, which provides unlimited transportation on Foothill Transit buses.

As Citrus College Promise participants, students will be required to fulfill several responsibilities, including enrolling full-time, applying for financial aid, signing an

IWCC pledge, completing a comprehensive student educational plan, meeting unit and GPA requirements, and enrolling in the English and math courses required for their major. To be eligible for the program, high school seniors must participate in Citrus College's Early Decision program. Home-schooled and private school students who live in the college's service area and signed up for an on-campus Early Decision event are also eligible.

“The introduction of the Citrus College Promise is a historic moment for the college and its surrounding communities,” said Dr. Geraldine M. Perri, superintendent/president of Citrus College. “Building upon our innovative efforts to increase student success and college completion rates, this program will change lives and transform communities by opening the doors of educational opportunity for hundreds of first-time college students.”

STRATEGIC PLAN IMPLEMENTATION

College Makes Strides Implementing Strategic Plan

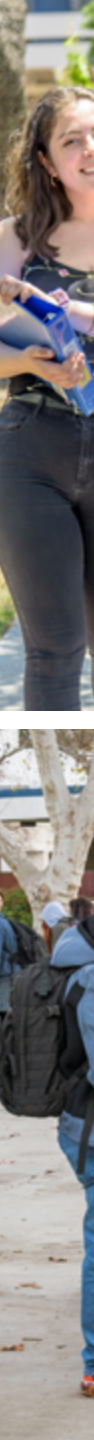
The Citrus College Strategic Plan: 2016-2021 is an ambitious and dynamic framework that is currently guiding the work of the institution for the next five years. Year two of this plan, which took place during the 2017-2018 academic year, saw many significant accomplishments.

One of the most impactful achievements was the development of the college's Enrollment Management Plan. The Enrollment Management Committee worked with Academic Affairs, Student Services, Technology and Computer Services (TeCS), and External Relations to implement key components of the plan. Notable activities included changing the registration pattern from four times to twice each year, increasing the number of Early Decision students by expanding to more out-of-district high schools, broadening the use of social media to promote attendance, dramatically growing the number of dual enrollment course offerings at high schools, and increasing the number of online courses.

To bolster these enrollment initiatives, Student Services worked with Academic Affairs to increase course offerings and recruitments for dual enrollment courses at the college's feeder high schools. The effort has proven successful, with 384 students enrolling in dual enrollment courses for the fall 2017 semester and 425 students enrolling for the spring 2018 semester, totaling 819 students for the 2017-2018 academic year. This is a 160-percent increase from the previous academic year, when only 315 students enrolled in the program.

A Multiple Measures Assessment Project (MMAP) "Strike Team" met regularly to plan and design activities as a result of the AB 705 state mandate, which requires students to enter and complete transfer-level coursework in English and math within a one-year timeframe using multiple measures placement, such as high school GPA and coursework. Training sessions were attended by over 50 English and math faculty in the fall 2017 semester. In March 2018, the college started using multiple measures criteria to place incoming new students in classes for the fall 2018 semester.

Online course offerings were increased during the academic year and enrollment in all online classes increased by 22 percent over the prior year. Additionally, the success rate of students taking these online courses increased by 5 percent, from 59 percent in the spring 2017 semester to 64 percent in the spring 2018 semester. These statistics





indicate the gap between traditional and online class success rates is narrowing.

Several technology innovations took place throughout the 2017-2018 academic year, as well. In addition to a redesign of the college website and a new my.citruscollege.edu portal, TeCS implemented an online application for international students, which eliminated the need to complete two applications; an online application for the honors program, which will pave the way for other electronic program applications; and an online transcript process, which enables the college to send and receive transcripts electronically. TeCS also replaced approximately 100 virtual desktop computers with new physical PCs in the library during December 2017 and January 2018. Students and faculty members rely on these computers to efficiently run software used for classroom instruction.

The college's Emergency Preparedness Task Force continued to review the Emergency Operations Plan and evaluate best practices. Citrus College conducted two emergency drills during the fall 2017 semester and one in the spring 2018 semester. Additionally, Campus Safety worked with the Office of Student Life and Leadership Development to promote emergency preparedness through trainings, workshops and a Coffee with a Cop event during Campus Safety Month in September 2017.

A Title IX work group coordinated with External Relations to develop a "Know Your Rights" poster, which has been placed throughout campus. At the beginning of the fall 2017 semester, a written summary of Title IX and instructions on how to report sexual abuse/harassment was also emailed to all students. Both Human Resources and Student Services are continuing to implement a college-wide awareness program to educate both students and employees.



Members of the board of trustees and college representatives attended more than 40 events in the community in 2017-2018, including activities with chambers of commerce, local municipalities, feeder school districts and more than 15 high-level meetings with local legislators. This proactive outreach included advocacy for legislation and funding favorable to community colleges. By the end of the spring 2018 semester, the college also hosted campus visits for several elected officials, including Assemblymember Blanca E. Rubio, State Senator Anthony Portantino and Los Angeles County Supervisor Kathryn Barger.

Finally, External Relations developed and implemented social media strategies to increase the frequency and quality of posts on the college's official social media accounts, including Facebook, Twitter and Instagram. Growth has exceeded expectations, with each platform experiencing double-digit percentage increases in

followers and likes between the fall 2017 and spring 2018 semesters.

This has been a fast-paced, dynamic year at Citrus College - one marked by innovation, progress and success. Through the Citrus College Strategic Plan: 2016-2021, as well as the commitment and dedication of the college community, the college remains on the leading edge of innovation in higher education. The strategic plan will continue to guide the college's efforts to shape the future of thousands of Citrus College students for years to come.



DISTINGUISHED FACULTY AWARD



Dale Salwak, Ph.D.

Citrus College English instructor Dale Salwak, Ph.D., has been honored with the Distinguished Faculty Award. With a teaching career spanning five decades, Dr. Salwak has educated thousands of students at the college. Renowned both inside the classroom for his innovative teaching methods and outside the classroom as a literary scholar, Dr. Salwak brings his passion for literature to every course he teaches. He currently teaches Shakespeare, Literature of the Bible, English Literature, Critical Thinking, and Reading and Composition. Highly regarded among his students and peers for his wit and ability to captivate an audience, Dr. Salwak excels at bringing literature to life.

In addition to his success in the classroom, Dr. Salwak is an internationally celebrated magician. His performances have taken him across several continents to dozens of countries, including North Korea on several occasions. When visiting the highly secluded nation, Dr. Salwak mentors North Korean magicians and works to bridge the gap between North Korea and the United States.

He has published 26 books, including his most recent, “Writers and Their Mothers.” He is a recipient of Purdue University’s Distinguished Alumni Award, as well as a research grant from the National Endowment for the Humanities. Dr. Salwak is also a frequent contributor to the (London) Times Higher Education magazine.

Dr. Salwak earned his bachelor’s degree in English with a minor in science and mathematics from Purdue University (1969) and his master’s degree (1970) and Ph.D. (1974) in English with a minor in religious studies from the University of Southern California, where he received a National Defense Education Act Title IV Fellowship. In 1973, while in the last year of his doctorate program, Dr. Salwak began teaching at Citrus College.

When asked what he is most proud of professionally, Dr. Salwak responded, “My students. They have made me.”

ABCD AWARD RECIPIENTS

Since 2013, Citrus College has honored outstanding classified employees with the Above and Beyond – Classified Development (ABCD) Award, conferred quarterly at board of trustees meetings. The award is given to classified employees who exhibit exceptional vision, collaboration, service and dedication to the college community.

These four individuals were ABCD Award recipients during the 2017-2018 academic year:



Ms. Cheryl Hall, administrative secretary II, was named the first ABCD Award recipient of the 2017-2018 academic year in August 2017. Ms. Hall was recognized for her calm and professional manner, her willingness to go above and beyond in serving students and faculty members, and for consistently demonstrating her commitment to Citrus College. When health sciences was without a director, the department was able to pull together as a team due to Ms. Hall's proactive approach and flexibility. Ms. Hall was nominated by her supervisor, Salima Allahbachayo, director of health sciences.



Recognized throughout her 17-year career at Citrus College for being an exemplary employee, **Ms. Denise Zamora**, Extended Opportunity Programs and Services (EOPS)/Cooperative Agencies Resources for Education (CARE) specialist and Citrus College alumna, received the ABCD Award at the October 2017 board meeting. Ms. Zamora is responsible for reviewing hundreds of applications each semester and documenting students' eligibility for the EOPS/CARE program. During the January 2018 board meeting, **Ms. Yueyi Huang**, research analyst, was presented with the ABCD Award. Ms. Huang began her career at Citrus College in 2014, and was recognized for being efficient, thorough, responsive, proactive and knowledgeable. Dr. Patricia A. Historic Building Renovation Celebrated

Men's Basketball: Champs of the Court and Classroom

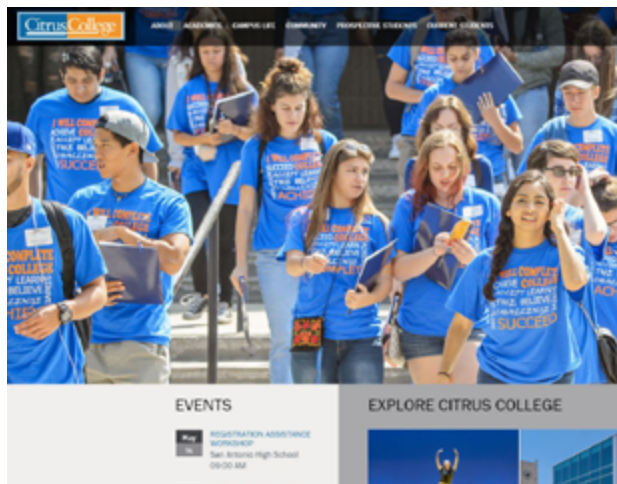

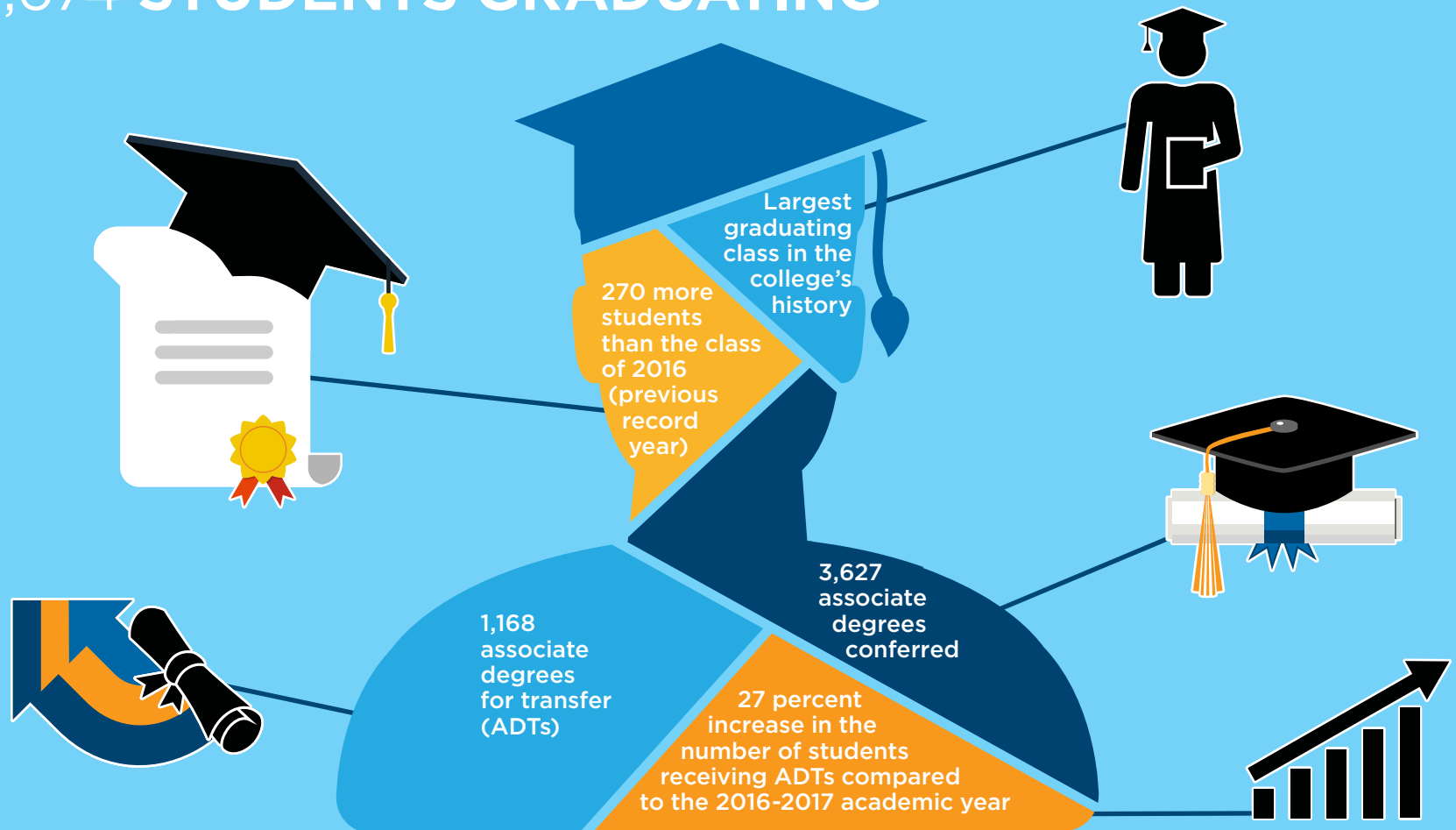
Social Media Outreach Recognized

RECORD-SETTING FINANCIAL GIFT



Nearly \$1.3 million has been given to the Citrus College Foundation by the estate of John W. Cassey, Ph.D., who served as a faculty member at Citrus College from 1960 to 2002. The bequest, which is designated to support student success, scholarships and faculty enrichment, is the largest in

the organization's history.

The funds will be used to establish the Dr. John William Cassey Endowed Scholarship, which will provide two scholarships to history and/or political science majors. They will also be used to endow the Patricia Knox Scholarship Fund, which was previously

established to benefit nursing students. In addition, Dr. Cassey's gift will endow faculty development programs, assist with equipment needs and help finance academic events for the history, political science and nursing programs.

"As a highly respected member of the college community for many decades, Dr. Cassey had a passion for learning and commitment to faculty enrichment that made a significant impact on the college and its students," said Stephen R. Baker, 2016-2018 president of the Citrus College Foundation Board of Directors. "Through careful and thoughtful estate planning, Dr. Cassey has ensured that his impact as an instructor will extend to future generations."

To celebrate Dr. Cassey's contribution and to honor his memory, the Citrus College Foundation installed a Faculty Enrichment Honor Wall, which will include the names of any donors who support faculty enrichment and the educational mission of Citrus College. Members of the college and local communities attended the wall's unveiling in the lobby of the Hayden Hall building on June 16 during the 2018 Alumni Reception following the college's commencement ceremony.



LOCAL EDUCATOR HONORED

Ms. Karen M. Cullen, a longtime resident of Glendora and a graduate of Citrus College, was selected to receive the 2018 Distinguished Alumni Award during the college's annual commencement ceremony in June. As a teacher and community volunteer, Ms. Cullen has directly impacted the lives of thousands of people throughout the San Gabriel Valley and beyond. Her devotion to helping others and desire to give back were partly influenced by her experiences as a college student.

During Ms. Cullen's years at Citrus College, she was an active member of the student body. She graduated in 1964 and transferred to the University of La Verne (formerly La Verne College). Ms. Cullen decided to pursue a career in education because of the positive influence of her Citrus College instructors. After graduating with her bachelor's degree in 1967, she earned her California teaching credential. She obtained her first position in January 1968 and spent the next 34 years teaching kindergarten through sixth grade at a variety of elementary schools throughout the country.

Although Ms. Cullen retired in 2001, her schedule has remained filled with a variety of service activities. In her spare time, she maintains her relationship with Citrus College by attending meetings of the Citrus Alumni & Friends Association. "Citrus College was instrumental in pointing me in the right direction as a young adult, guiding me to a fulfilling life of service to others," she said. "I have always felt very connected to this great place of higher learning."

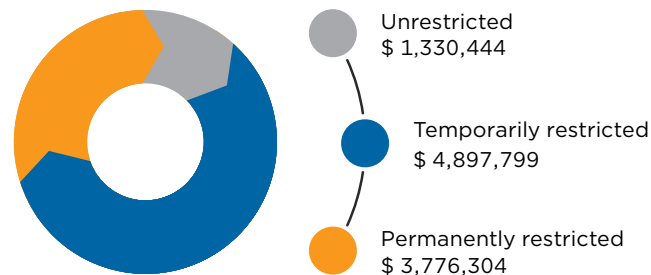

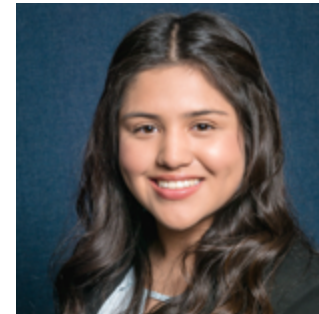

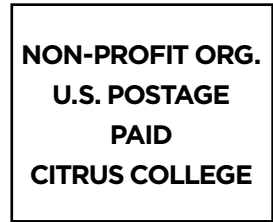
