

Standard flow of review.

1. BP/AP received by no later than 4 pm on the agenda due date.
2. BP/AP charter dispatched to the Senate Review Team.
 - a. An email is sent to notify all faculty of the BP/AP for review and the assigned Senate Review Team.
 - b. CCFA Liaison is notified by email of the BP/AP for review
3. All parties will begin reviewing and documenting questions and comments on the Senate Charter form.
4. The BP/AP will be listed on the agenda as New Business.
 - a. If the review is complete, the item will be discussed, and the issues and comments will be discussed in Senate with the hope of creating a near-finished product. The item will come back as an Action Item.
 1. If an item becomes contested, it will come back as a Second Read.
 - b. If the review is incomplete, the review's process will be discussed, and the Senate will be updated on what items still need to be answered or resolved. The item will come back as a Second Read at the following meeting.
