Self-Reflection... the Institutional Self-Evaluation Report (ISER)

Peer Review. . . Team ISER Review and the Focused Visit

Affirmation. . . the Commission's Action

On-going. . . Commitment to Improvement and Educational Excellence



Peer Review. . . Team ISER Review and the Focused Visit

Formative

- College submits ISER a semester prior to the visit
- Peer review team conducts Team ISER Review
- Verify compliance with standards; does not need onsite verification
- Specify additional information needs, or processes for further development
- Identify focused "Core Inquiries" that will be pursued during the on-site visit

Summative

- Smaller team and/or shorter visit schedule
- Conducts the Focused Site Visit
- Completes peer review team report leading to summative findings



Formative / Summative Peer Review Process





Beginning the Process

ACCJC Training for college leaders (February 2019)



Standards Teams (Formed the teams, making sure members from all of our constituent groups part of each team. Provided training for all teams)



Evidence / Dialogue / Drafts

Fall 2019 – gathered evidence, held multiple meetings and drafted first response

Winter/Spring 2020 –

Co-chairs reviewed, assessed and provided comments to Standard Co-leads.





Timeline



Summer – Edit the entire Institutional Self-Evaluation Report (ISER)

Fall – Provide overview at shared governance committee meetings. Post draft online for review and comments.

Late Fall – Board of Trustee First and Second Readings



Timeline

Early Spring 2021 – Submit approved ISER in January

Spring – Receive core inquiry from ACCJC evaluation team (Formative Evaluation)

Fall – Focused site visit (Summative Evaluation)
