Program Description:



CFTE also trains Citrus College Faculty on Instructional Technology to improve technology pedagogy for instructional purposes.

2. Key functions/goals of this Department/Program:

Key functions/goals include:

- Improving the Education Career Pathway for Students by providing teacher related workshops/events and articulation agreements to facilitate the transfer process.
- Establishing a Scholastic Technology Literacy Summer Camp for Students in order to teach them to integrate technology into learning and research in an academic setting.
- Creating an Academy for Faculty Instructional Technology in Course Cohorts to improve technology pedagogy for instructional faculty.
