## **CORONAVIRUS (COVID-19) EXPOSURE NOTIFICATION**

Dear Citrus College Students and Colleagues,

I am writing to inform you that the college has recently received information about **five** confirmed cases of Coronavirus 2019 (COVID-19). The COVID-19 cases were present on campus as follows:

- 1) **adapted physical education area (Adapted Physical Education Building, AP) on Monday, January 3 and Tuesday, January 4, 2022 from 8:20 a.m. to 9:40 a.m.**
- 2) **Campus Center (CC) on Wednesday, January 5 and Thursday, January 6, 2022 from 9 a.m. to 5 p.m.**
- 3) **institutional research, planning, and effectiveness office in the Center for Innovation Building (CI 144) from Monday, January 3 through Wednesday, January 5, 2022 from 8 a.m. to 5 p.m.**
- 4) **automotive lab in the Automotive Annex (AA) on Thursday, January 6, 2022 from 11 a.m. to 1 p.m.**
- 5) **Professional Center (PC) and Technology Center (TC) – first and second floors of both buildings – from Monday, January 3 through Friday, January 7, 2022 from 3:30 p.m. to 11:30 p.m.**

Those who may have been in the area(s) or had contact with the individual(s) mentioned have been notified. Cleaning of the exposed location(s) is/are in progress. If you were in the identified area(s) during the date(s) and time(s) indicated and you have not already been contacted by the college, please contact Shauna Bigby, college nurse, via email at [sbigby@citruscollege.edu](mailto:sbigby@citruscollege.edu).

The following guidelines are offered as precautionary measures:

- Wear a face covering (mask) as currently required by the County of Los Angeles Department of Public Health while indoors regardless of vaccination status.
- Stay home when you are sick. Anyone with symptoms consistent with COVID-19 should remain at home in isolation for a minimum of 10 days plus at least three days after the resolution of fever (without fever-reducing medication) and improvement in other symptoms. District provided COVID-19 sick leave (80 hours) is available to full-time employees in addition to regular sick leave.
- Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use alcohol-based hand sanitizers that contain at least 60% alcohol.

- Cover your coughs and sneezes with a tissue, and then dispose of the tissue and clean your hands immediately. If you do not have a tissue, use your sleeve, not your hands, to cover your coughs and sneezes.
- Limit close contact with people who are sick, and avoid sharing food, drinks or utensils.
- Clean and disinfect frequently touched objects and surfaces using a regular household cleaning spray or wipes.
