## **CORONAVIRUS (COVID-19) EXPOSURE NOTIFICATION**

Dear Citrus College Students and Colleagues,

I am writing to inform you the college has recently received information about **two confirmed cases** of Coronavirus 2019 (COVID-19). The COVID-19 cases were present in the following location(s):

- **Student Services Building (second floor, SS 218) on Tuesday, August 16, 2022 from 7 a.m. to 2 p.m.**
- **Student Services Building (second floor, SS 218) on Wednesday, August 17, 2022 from 7 a.m. to 6 p.m.**
- **Campus Center (CC, counselor training session) on Wednesday, August 17, 2022 from 10 a.m. to 1 p.m.**
- **Student Services Building (second floor, SS 252) on Wednesday, August 17, 2022 from 8:30 a.m. to 9:45 a.m. and 1:15 p.m. to 2:30 p.m.**
- **Hayden Hall Building (HH, counselor training session) on Thursday, August 18, 2022 from 1 p.m. to 3:45 p.m.**

If you were in these location(s) on the date(s) and time(s) indicated, you are deemed to be in close contact with the COVID-19 case(s) and must follow the requirements below.

Pursuant to recent protocol changes instituted by the California Department of Public Health and the County of Los Angeles Department of Public Health, as a close contact with a COVID-19 case, you are no longer required to quarantine and you may continue to attend your on-campus classes/activities provided you do not develop COVID-19 symptoms or test positive for COVID-19.

You are required to:

1. wear a mask while around others (on and off campus) for a period of 10 days starting on the day after the date of the close contact;
2. get tested for COVID-19 three to five days after your exposure (you may get tested at the on-campus test site as part of your required weekly testing); **and**
3. monitor yourself over the next 10 days for any COVID-19 related symptoms and continue to use the daily pre-screening on the Citrus Mobile app.

COVID-19 related symptoms include: fever of 100.4 or higher, chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny

nose, nausea or vomiting, or diarrhea, unless a licensed healthcare professional determines that any of these symptoms were caused by a known condition other than COVID-19.

If you develop COVID-19 related symptoms or test positive for COVID-19, you must follow the isolation protocols and remain off campus. Please contact the district's nurse, Dr. Shauna Bigby at [shc@citruscollege.edu](mailto:shc@citruscollege.edu), for further instruction.
