# \*\*\* STRONG ARM ROBBERY \*\*\*

### TO THE CITRUS COLLEGE COMMUNITY

MAY 30, 2018

In compliance with the "Timely Warning" provisions of the federal Jeanne Clery Disclosure of Campus Security Policy and Campus Crimes Statistics Act of 1998, the Department of Campus Safety is giving notice of a strong arm robbery reported to have occurred on campus. The purpose of this Timely Warning is to raise campus awareness as it is the duty of the institution to warn the community of this incident.

On Tuesday, May 29, 2018 at approximately 1:40 p.m., Campus Safety responded to the S1 parking lot regarding suspicious circumstances in progress. The reporting party stated an unknown male was on the hood of a vehicle as it was driving erratically through the parking lot. Upon Campus Safety's arrival, they located the male who was no longer on the hood of the vehicle. The male driver and the vehicle were not located. The male, who was not a student, reported he was robbed at knifepoint while in the men's restroom between the Performing Arts Center and the Box Office. After being robbed of his money, the male victim chased after the male suspect who subsequently got into his parked vehicle in the S1 parking lot. As the suspect drove away, the victim jumped on the hood of the vehicle in an attempt to stop the suspect, but was unsuccessful. The vehicle then proceeded southbound on Citrus Avenue. The Glendora Police Department (GPD) also responded but did not locate the vehicle or the suspect. No students were physically injured as a result of this incident.

### SUSPECT INFORMATION:

## Description:

Hispanic male, 28-32 years, black hair, brown eyes, slender build, thin beard, with tattoos on both arms and a three letter tattoo on the back of his head;

Wearing grey basketball shorts, a white sleeveless shirt and black Vans.

Vehicle Description: White, newer model, two door, Infinity G35 with lightly tinted windows.

#### **SAFETY TIPS**

- Program the phone number for Campus Safety into your phone (626) 914-8611.
- Report any unusual or suspicious activity to Campus Safety immediately. Reports can be made via phone call to Campus Safety or via text by utilizing the text-a-tip function on the **Campus Safety mobile app, Citrus Guardian.**
- Be aware of people around you and stay alert to your surroundings.
- When possible, avoid walking alone. Walk with a friend or walk in well-traveled areas.
- Do not get into a stranger's vehicle.
- If on campus, utilize the safety escort services provided by Campus Safety.
- Stay in well lighted areas.
- Avoid places where you are vulnerable and there are no exits.
- Walk with confidence; show that you are aware and in control.
- If you are being followed, go to the nearest business or residence for help.
- If you are harassed by the occupants of a car, turn and walk in the other direction. The driver will have to turn around to follow you.
