RE: COVID-19 Exposure Notification

Dear Citrus College Students and Colleagues,

I am writing to inform you the college has recently received information about the following confirmed case of Coronavirus 2019 (COVID-19). The COVID-19 case was present in the following location(s):

Liberal Arts/Business Building (second floor, LB 202) on Tuesday, April 26, 2022 from 11:30 a.m. to 12:55 p.m.

Those who were in this class or had contact with the COVID-19 case have been notified. If you were in this class and have not already been notified, the following provides the most recent protocols for a person who was exposed to a person with COVID-19.

Pursuant to recent protocol changes instituted by the California Department of Public Health and the County of Los Angeles Department of Public Health, as a close contact with a COVID-19 case, you are no longer required to quarantine and you may continue to attend your on-campus classes/activities provided you do not develop COVID-19 symptoms or test positive for COVID-19.

You are required to:

1. wear a mask while around others (on and off campus) for a period of 10 days (an end date of May 7, 2022);
2. get tested for COVID-19 three to five days after your exposure (you may get tested at the on-campus test site as part of your required weekly testing); **and**
3. monitor yourself over the next 10 days for any COVID-19 related symptoms.

COVID-19 related symptoms include: fever of 100.4 or higher, chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, or diarrhea, unless a licensed healthcare professional determines that any of these symptoms were caused by a known condition other than COVID-19.

If you develop COVID-19 related symptoms or test positive for COVID-19, you must follow the isolation protocols. Please contact the district's nurse, Dr. Shauna Bigby at shc@citruscollege.edu, for further instruction.
