### Message to Our Community



In 2004, Citrus Community College District voters passed the Measure G Bond, a visionary decision that has allowed Citrus College to construct and renovate facilities essential to delivering a high-quality college education. As a resident and a parent, I have followed the progress of the college's building projects with great interest, hoping that one day my daughter will choose this fine institution as her first step in earning a college degree.

Therefore, on behalf of the Measure G Citizens' Oversight Committee, I am proud to share the committee's 10th Annual Report. While this report demonstrates that our tax dollars are allocated carefully and spent prudently,

we are honored to present examples of how Measure G has enabled Citrus College to provide a quality education, earning the institution honors and accolades at the national, state, and local levels as one of the best community colleges in the United States.

### **Committee Findings**

The Committee received and reviewed the financial and performance audits for the Citrus Community College District Measure G Bond Construction Program for the fiscal year ended June 30, 2015. Vicenti, Lloyd & Stutzman, LLP, an independent certified public accounting firm performed the audits, which included an examination of the District's compliance with the financial and performance requirements of the Proposition 39 Measure G General Obligation Bonds under Section 1(b)(3)(C) of Article XIIIA of the California Constitution. The auditors concluded that the District complied, in all significant respects, with the requirements of Proposition 39.

The auditors further concluded that the District's Measure G financial statements present fairly, in all material respects, the financial position of the Citrus Community College District Measure G Bond Construction Fund for the fiscal year ended June 30, 2015.

### **Committee Recognition**

The Committee congratulates Fred Diamond, director of facilities and construction, for receiving the California Community College Board of Governors 2015 Sustainability Award. Mr. Diamond was recognized for his leadership in advancing sustainability and environmental stewardship among the 113 community colleges in the state.

Citrus College has benefitted greatly from Mr. Diamond's leadership and expertise in the area of sustainability. For example, between 2013 and 2015, the college saved more than 1 million kilowatt hours, a significant reduction in its carbon footprint.

### **Building Facilities for Student Success**

Since 1915, Citrus College and the communities it serves have worked together to provide a safe and modern infrastructure that facilitates student achievement and college completion. The following Measure G projects are a few examples of the buildings and amenities that have enabled Citrus College to earn numerous awards and recognitions at the national, state, and local levels.

### Student Services Building



The Student Services Building, which opened in 2011, houses Admissions and Records, Financial Aid, Student Health Center, International Students Center, Counseling, and the Transfer Center.

### Top 100 Associate Degree Producer, 2015

Community College Week magazine named Citrus College among its top 100 associate degree producers in the U.S. for the seventh consecutive year. The college was listed in seven categories, including total associate degree conferrals.

### Stadium and Sports Facilities



Citrus College's sports facilities have undergone several upgrades: new lighting and turf (2005-2006), a softball field and field house (2008-2009), and a concession stand (2009). The Citrus College Stadium, where Commencement is held every June, also hosts our local high schools' sporting events and graduation ceremonies.

### Record Breaking Number of Degrees Conferred

Since 2011, Citrus College has more than doubled the number of associate degrees conferred during commencement, exceeding its all-time high for five consecutive years.

### Mathematics/Science Building



The Mathematics/Science Building, which was dedicated in fall 2005, is the home of the STEM Center.

### **Award-Winning STEM Program**

Citrus College's science, technology, engineering and mathematics (STEM) programs earned a "STEM Jobs Approved College" designation from Victory Media in 2014. In 2015, the STEM Summer Research Program received the Student Success Award from the California Community Colleges Chancellor's Office.

### Vocational Technical Building - Career Technical Preparation



The Vocational Technical Building, dedicated in 2010, houses the automotive technology, heating and air conditioning, and administration of justice programs.

Citrus College offers certificates of achievement in 55 programs of study. The number of certificates awarded has increased 158% since 2014. This accomplishment earned recognitions from both the Brookings Institution and PayScale, Inc., based on the average earnings of Citrus College alumni.

### Visual Arts Building



The Visual Arts Building is the final new building construction project under Measure G. The 37,000 square-foot building will enhance the college's visual arts program by providing 74 classrooms; an art gallery; computer labs; drawing, painting and printing studios; a ceramics lab, and lecture space. In addition, the *Clarion*, the college's student newspaper and recipient of numerous Journalism Association of Community Colleges awards, will relocate there. The Citrus College Visual Arts Building will open in Summer 2016.
