## PROGRAM DESCRIPTION

The program is unique in that one of its goals is to ensure the continuation of quality student representation in the participatory decision making efforts of the district. The program seeks to instill within its students a practical sense of the dynamics of leadership within an organization and some of the techniques that leaders utilize to enhance the effectiveness of the group as well as how to run meetings through the proper use of parliamentary procedure. In addition, the program places a heavy emphasis on self-knowledge based on reflection as the cornerstone of leadership.

For those students who take part in the program in excess of four semesters, the program shifts its emphasis to the principles and techniques involved in mentoring less experienced group members and the importance of transmitting group culture and providing for succession.

# **QUALITY**

#### **COMMENDATIONS**

- a. The faculty member who teaches our social science classes in this discipline meets district qualifications.
- b. Social science courses demand active participation by students in leadership roles on campus.

- c. The Associated Students Constitution requires a cumulative GPA of at least 2.5 for the President, Vice President, Legislative Liaison, Student Trustee, and Student Trustee Elect.
- d. The Associated Students Constitution requires a cumulative GPA of at lease 2.3 for all other officers.
- e. All social science leadership students must be currently enrolled in at least seven units.

#### RECOMMENDATIONS

- a. Continue to maintain high standards and GPA prerequisites for participation by students in the social science program.
- b. Continue to encourage students in leadership roles by all of our social science students, thus retaining the cultural diversity demonstrated by the program in the past.

# **FEASIBILITY**

#### **COMMENDATIONS**

- a. The room and equipment presently being used (located in the student center) meet the needs of the program; it is anticipated that they will continue to do so for the foreseeable future.
- b. The Associate Dean of Students works actively and closely with the leadership students, giving them the opportunity to develop their leadership skills.
- a. In order to enroll in either of the two program courses (Social Science 101 Student Government, and Social Science 102 Student Government), a student must hold a position on the Executive Board of the Associated Students of Citrus College. Also, each Executive Board member must be currently enrolled in either SOCS 101 or 102.

#### RECOMMENDATIONS

- a. Continue to require that students who wish to enroll in either SOCS 101 or 102 must also hold a position on the Executive Board of the Associated Students.
- b. Continue to require that students who wish to serve on the Executive Board must also be enrolled at the same time in either SOCS 101 or 102.
