Re:	Summer/Fall 2021 Updates

I hope you are all doing well. Although it's hard to believe that most of us have been working and learning in a remote environment for more than a year, it feels good to know that we are moving closer to a return of in-person activities. These past 14 months have both challenged our institution and renewed our sense of commitment and purpose. As superintendent/president, I want to thank you for being patient as we've begun to welcome more students, faculty and staff to campus while adhering to local protocols and prioritizing health and safety. As we reach the end of the semester, I wanted to update you on the college's return-to-campus plans for summer and fall.

The college <u>reopening plan</u> consists of an incremental return of students, faculty and staff based on the assigned tier level from the state's "Blueprint for a Safer Economy." As of May 25, 2021, Los Angeles County is in Tier 4, which is the least restrictive tier (Yellow). This means that additional programs, students and employees can begin returning to campus in a safe manner.

While you can read additional information in the reopening plan and in Human Resources COVID-19 updates, below is a brief recap:

## Summer 2021 on-campus programs:

- Health sciences including registered nursing, LVN and EMT
- Career technical education automotive and medium heavy truck
- Cosmetology lab classes
- Science labs including chemistry and earth sciences
- **Visual and performing arts** –additional visual arts, dance, theatre, vocal, and instrumental techniques, as well as performance-based academy
- Athletics practice and conditioning related to football, basketball, volleyball, soccer, water polo, cross-country, and swimming
- Kinesiology lab and activity-based classes
- Library limited services to provide students with access to books for check-out

## Fall 2021 on-campus programs and services (in addition to those mentioned above):

- Esthetician labs
- Journalism
- Additional science labs including astronomy, chemistry, biology, earth sciences, and physics

- Additional visual and performing arts classes
- Additional lab and activity-based kinesiology classes
- Additional on-campus classes and academic/student support services may be added as warranted and in compliance with state and local COVID-19 protocols

## Employees:

While there are still many unknowns, such as the proposed lifting of COVID-19 restrictions in California on June 15, it is important to plan for a number of scenarios. It is expected that there will be more flexibility in the Los Angeles County Department of Public Health's protocols, which will allow for additional staff to return to campus. As such, plans are currently being created to tentatively return classified staff, managers, supervisors and confidential employees, to campus on August 2, 2021, consistent with all state and county protocols. Discussions are currently taking place with employee groups in order to collaborate on these return-to-campus plans.
