

Masks/Face Coverings are Required Indoors

Students are required to wear proper face coverings while indoors, on campus, to prevent the spread of COVID-19. Members of the campus community found not wearing a proper face covering will be asked to comply or leave campus. Where required, face coverings must cover nose and mouth securely under the chin.

Daily Screening Requirement for On-Campus Instruction and Activities


Citrus College requires all employees and students to conduct a self-assessment for COVID-19 related symptoms when coming to campus, and to scan in to buildings visited in order to aid in contact tracing.

Location Check-In Requirement for On-Campus Instruction and Activities

At the entrance to all campus buildings, you will find a location check-in QR code. All students, staff, and campus visitors must use the CitrusMobile App and scan this QR code prior to entering. Citrus College will only be able to effectively contract trace potential positive COVID-19 cases when our campus community uses this check-in system.



COVID-19 Mandatory Weekly Testing Requirement for Students Enrolled in On-Campus Classes or Activities Beginning September 2021

Students will be required to take a rapid COVID-19 test once per week for the duration of the semester. This test will be conducted on campus and at no cost to the student. More detailed information will be sent to you as to when and where to go for your test.

COVID-19 Vaccination:

Citrus College strongly encourages our students to be vaccinated. The spread of the Delta variant has impacted the age group from 20 to 35 years old and being vaccinated has proven to reduce the spread of COVID-19 and lessen the health impact if you do contract COVID-19.

Failure to Comply

Students are required to comply with clearly indicated safety precautions and reasonable requests of college employees and campus safety.
